The Bermuda Sailing Association, its officers, Race Committee, race volunteers, members and employees accept no liability or responsibility for property damage to any boat or yacht, or personal injury to any skipper, crew or acquaintance participating in any way in this regatta, including pre-race and post-race activities. The term skipper as used in this form shall mean the person, whether or not the owner of the boat or yacht, who is designated on the entry form as the skipper and who is in charge of the boat or yacht. The suitability of the boat or yacht for the weather expected is the sole responsibility of the skipper, as is the decision to start or continue to race. The skipper shall be responsible for the boat or yacht, its handling and safety, and for his or her conduct and that of any crew, while afloat or ashore. It is also the responsibility of the skipper to read and comply with the Notice of Race (NOR) and the Sailing Instructions (SI), and to be familiar with the conditions of the race. I hereby apply to participate in 2016 Heineken Around the Islands Race. In consideration of your accepting my application I agree to abide by the Sailing Instructions and the conditions of the race. I have evaluated the condition of my boat or yacht, and the abilities of myself and crew. I am familiar with yacht racing of this type, the level of competition and conditions normally experienced, and the waters on which this regatta will be conducted, and have made the decision to participate.
